Master program "Information Technologies in Economics" has as objective to provide students with the engineering principles of information technology and the business context in which information technology decisions are made, so that they can implement better information technology solutions that reflect the demands of today's evolving business environment.



Master program "Information Systems Security" is a double degree study program of the Academy of Economic Studies of Moldova and University of West Attica from Greece. The selection of candidates is made from the number of those enrolled in ASEM, full-time studies, in descending order of enrollment averages. Academic mobility expected for year 1 of studies, semester 2 at West Attica University, Greece. For the mobility semester, the credits from the partner university are equivalent to those from ASEM. At the end of the studies, graduate benefit from two diplomas: ASEM specialty "Information Systems Security" and UNIWA specialty "Cyber Security".
